

ALL ABOUT the International Society for the Study of Chinese Overseas 世界海外华人研究学会 1992-2010

A brief report by Teresita Ang See, Secretary-Treasurer, ISSCO

ISSCO, the International Society for the Study of Chinese Overseas, is a scholarly, non-political, non-profit professional society of individuals and institutions interested in and committed to the study of Chinese overseas.

The primary purposes of the society are to advance research and scholarly exchange in the study of Chinese overseas, to promote avenues for research and publications, and to organise and support national and international conferences.

ISSCO was established in 1992 at the culmination of the first ISSCO international conference convened jointly with the Department of Ethnic Studies of the University of California at Berkeley, U.S.A. Professor Wang Gungwu, then Vice-Chancellor of Hong Kong University and now with National University of Singapore, was appointed President; Professor Wang Ling-chi, Department of Ethnic Studies, UC Berkeley, as Secretary-Treasurer; and Teresita Ang See, of Kaisa Para Sa Kaunlaran in Manila as Vice President.

Aside from the three officers, ISSCO by-laws provide for the election of 12 other Board members representing Southeast Asia, Northeast Asia, Europe, North America, Latin America, Africa, Oceania, China, Taiwan, Hong Kong and two at large representatives.

ISSCO holds one major international conference every three years and two regional conferences in between. The regional conferences are usually held in cooperation with other institutions.

Journal of Chinese Overseas

The official journal of ISSCO is *The Journal of Chinese Overseas* which is published twice a year in May and November. This cross-disciplinary journal publishes research articles, reports, and book reviews on Chinese overseas throughout the world, and the communities from which they trace their origins. Moving across regions and disciplines, the Journal will examine “Chineseness” in its many diverse settings.

Dr. Tan Chee Beng of the Chinese University of Hong Kong has served as its editor-in-chief and Dr. Wang Gungwu as Chairman of the Editorial Board since its inception in 2005. With a Board of Editors drawn from fields as diverse as history, anthropology, sociology, geography, cultural studies, and political science, the Journal contributes to transnational studies, as well as the study of Chinese communities in specific national settings.

Journal of Chinese Overseas was published by Singapore University Press (NUS Press) from 2005 to 2008. Since 2009, JCO has been published by Brill for the Chinese Heritage Centre under the auspices of the International Society for the Studies of Chinese Overseas, with the sponsorship of the Lee Foundation.
